UEE22025 Certificate II in Electrotechnology (Career Start) Big Sister Electrical Pre-Apprenticeship



OVERVIEW

This qualification is designed to provide women with industry specific training to gain skills, knowledge and behaviours to enable transition into an apprenticeship in the Electrotechnology Industry.

This nationally accredited qualification provides a strong foundation in safety, communication and teamwork, along with valuable work placement experience.

Delivered with support from the Big Sister Program, part of the Australian Government's Building Women's Careers initiative, participants receive mentoring from experienced women in the trade, placement with supportive employers, and access to industry networking opportunities.

CONTENT

This course has 8 core, 5 elective and 4 work placement units of competency - visit cet.asn.au to view the unit details.

REQUIREMENTS

This qualification is delivered under pre-apprenticeship arrangements.

All applicants are required to undertake a literacy and numeracy readiness assessment administered by the College.

The test is of a Year 11-12 level and is specific to transposition of formula, trigonometric ratio and algebra. Candidates who have not yet completed year 10 studies are welcome to sit the readiness assessment.

Applicants who meet the course requirements will be invited to complete an Admission Statement and, if deemed necessary by the college, attend an interview. Your suitability for the program will be assessed based on your readiness assessment, Admission Statement, and potential interview.

To be able to complete on the job work placement, students must be able to obtain an Electrical Training Licence. The application process will commence on the first day of the course. The current licence fee is \$88.00, payable by the student.

DURATION

Up to 16 weeks full time.

PRICE

The tuition fees* are set by the WA Department of Training and Workforce Development. This course is currently categorised as FEE-FREE which means there are no tuition fees charged. Resource fees may be covered by the Big Sister Program or the Electrotechnology Training Institute (ETI), subject to funding availability and agreed enrolment targets. Applicants will be advised in their acceptance letter whether they are eligible for resource fee funding.

* The student tuition fees are indicative only and are subject to change given individual circumstances at enrolment. Additional fees may apply such as student service fees.
